



Simple ideas to help keep your students on track

Incorporate these ideas, provided by *Adventures* in *Education*, into your counselor calendar to help better prepare your students for college and beyond!

Counselor Checklist

- Advertise college entrance exam test dates and registration deadlines.
- Remind seniors to turn in all required college forms needed in January to the appropriate school officials.
- Alert parents of seniors who failed a course that is required for graduation.
- Organize your distribution and interpretation of PLAN and PSAT results to students. A parent/student meeting in January is a great way to distribute the test results and get the juniors organized for spring/summer campus visits and taking the SAT/ACT.
- Advertise the availability and location of the FAFSA on the Web (www.fafsa.gov).
- Remind senior males that they must register for the Selective Service 30 days before or after their 18th birthday to be eligible to receive government financial assistance for college.
- Conduct a financial aid night this month for senior students and parents. Contact us or a financial aid officer from a nearby college to make the presentation.
- · Post and advertise scholarships.

Easy Ideas

- Financial aid help Ask a financial aid officer
 from a local college or university to be
 available on your campus one day after school
 for a couple of hours to answer specific
 questions about the FAFSA. Advertise this
 assistance to students and parents.
- Junior lunch bunch Conduct weekly lunch sessions in your office or a classroom for juniors (5-8 at a time) to provide them with an opportunity to ask questions and discuss college preparation. With busy junior schedules, lunch may be their only free time. This activity also allows you to be time efficient — better five at a time than one at a time.
- Host workshops Local colleges and universities in your area may also be conducting financial aid workshops for high school counselors.
- Review college acceptance letters Seniors are now receiving acceptance letters from colleges. Collect copies of the letters and start a bulletin board that lists colleges and the names of accepted students. Students enjoy this and can connect with other students accepted to the same school. This is a good way to help students find potential roommates!
- Distribute the Senior Spring Checklist Print out and distribute the Senior Spring Checklist (www.AIE.org/Handouts/SeniorSpringChecklist.pdf) to students.

January

 Submit your Free Application for Federal Student Aid (FAFSA) as

soon as you can. Check the colleges you're interested in to see if they have a financial aid priority deadline.

- Submit other financial aid forms that may be required – And keep copies.
- If a college wants to see your midyear grades, give the form to your school counselor.
- Review your transcript to make sure that you have received credit for all of your coursework.
- Make a list of your extracurricular activities for use in filling out college applications.
- If you have a college interview, be sure to be fully prepared – take a transcript and resume with you. This is your opportunity to share information about yourself that was not covered in your application. Remember to follow-up the interview with a thank you note.

January

 Make sure you are on track to complete all required courses for graduation. Review your transcript to verify that it correctly reflects all your coursework.

- Complete any necessary paperwork to register for your senior year courses. And make sure your course choices are appropriate for your prospective colleges' admission requirements.
- Choose solid academic classes. These include English, math, science, social studies, and foreign languages.
- Start thinking about what you want to study in college.
- Meet with your school counselor to talk about the colleges you are interested in, what entrance exams you should take, and when you should take them.
- Register for the SAT if you want to take it in March.

February

- Contact your colleges to confirm that all application materials have been received.
- After you submit the FAFSA, you will receive your Student Aid Report (SAR). Make any corrections necessary and submit them to the FAFSA processor.
- If any special circumstances affect your family's financial situation, alert each college's financial aid office.
- Complete any last scholarship applications.
- · Register for AP Exams you want to take.
- College campus visits are a critical step in making that final decision. Take a tour of prospective colleges. You'll get a thorough view of the campus and tour guides are a great source of information.
- Meet with an admissions representative to answer any additional questions you may have.

February

- Think about which teachers you will ask to write letters of recommendation.
- If you're in Advanced Placement Program (AP) classes, register for AP Exams, given in May.
- Ask your counselor or teacher about taking the SAT Subject Tests in the Spring.
- Start searching for scholarships. Some deadlines fall as early as the summer between 11th and 12th grades, so prepare now to submit applications soon.
- Research prospective colleges.
- Take a tour of prospective colleges. You'll get a thorough view of the campus and tour guides are a great source of information.
- Meet with an admissions representative. He
 or she will review the college's admission
 criteria and help you understand the
 application process.
